Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the Aradhana P.T.C. College, Shree Prantij Taluka Kelavani Trust, Shantivan Campus, GH-06 Road, Sector-28 Gandhinagar-382028 Gujarat by affidavit dt. 16.01.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed**, which require additional facilities
- 3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
 - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Aradhana P.T.C. College, Shree Prantij Taluka Kelavani Trust, Shantivan Campus, GH-06 Road, Sector-28 Gandhinagar-382028 Gujarat for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

) Name of faculty members who left or joined during the last, quarter:

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i) The affidavit with enclosure submitted along with application.

j) The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/2-32/323201/76/2005/6903 dt. 23.08.2005 be treated as cancelled from the date of issue of this revised order.

RESTORATON ORDER

WHEREAS, the institution, namely, Aradhana P.T.C. College, Shree Prantij Taluka Kelavani Trust, Shantivan Campus, GH-6 Road, Sector-28 Gandhinagar-382028, Gujarat was granted recognition by WRC, NCTE for B.Ed. course of one year duration with an annual intake of 100 students vide order No.WRC/2-32/323201/76/2005/6903 dated 23.08.2005. The name of institution in the recognition order has been corrected as "Aradhana College of Education" in place of "Aradhana PTC College" vide letter No.WRC/NCTE/323201/2006/4685-88 dated 04.05.2006.

- 2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, revised order was issued to the institution vide No.WRC/323201/2015/146182,185,188,193,196,199,200,202 dated 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.
- 3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice WAS issued to the institution dated 05.08.2016.
- 4. **AND WHEREAS**, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 12.08.2016 received in WRC on 17.08.2016.
- 5. **AND WHEREAS**, the matter was considered by WRC in its 283rd WRC meeting held on November 14-15, 2017 and the Committee decided as under:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and additional Reserve Fund of Rs. 4.00 lakhs should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

Accordingly, show cause notice was issued to the institution dated 17.11.2017.

- 6. **AND WHEREAS**, in response to show cause notice, the institution has submitted reply vide letter dated 28.11.2017 received in WRC on 01.12.2017.
- 7. **AND WHEREAS**, the matter was considered in the 366th WRC meeting held on July 12th & 14th, 2022 and the Committee decided as under:

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

SHOW CAUSE NOTICE was issued 05.08.2016, 17.11.2017.

- The institution has submitted the building completion certificate wherein the total land area is not mentioned.
- FDRs of Rs. 7 lakhs as Endowment Fund, and of Rs. 5 lakhs as Reverse Fund in joint operation with Regional Director, WRC (NCTE) not submitted.
- The institution has not submitted the approval qualified staff as per the NCTE norms
- Necessary information has not been uploaded on its website.
- The institution has also not submitted the filled copy of the Performance Appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993, with effect from the end of the academic session next following the date of communication of the said order."

Accordingly, Withdrawal Order was issued to the institution dated 28.10.2022.

- 8. **AND WHEREAS**, the matter was considered in the 374th (Part-2) meeting of WRC held on October 18-19, 2022, and the Committee has decided the following:-
 - "...Therefore, in view of the above, the Committee decided to issue a Show Cause Notice before withdrawal of recognition under Section 17 of NCTE Act, 1993 to the below mentioned Teacher Training Institutions which have failed to submit PAR for the academic session 2020-2021 and the reply to the same should be submitted by the institutions within a period of 30 days from the date of uploading of the minutes on the official website of NCTE."
- 9. **AND WHEREAS**, institution filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order dated **30.11.2022** decided as follows:-
 - "...After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee council concluded to remand back the case to WRC with a direction to consider documents submitted in appeal which are required to be sent to them by the appellant

Institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The WRC is at a liberty to verify the submitted documents from the concerned issuing authority.

The above decision is being communicated on behalf of the Appeal Committee."

10. **AND WHEREAS**, the matter was considered in the 377th (Part-1) meeting of WRC held on December 10, 2022, and the Committee has decided the following:-

"...In view of the above, the Committee decided to issue Final Show Cause Notice before withdrawal of recognition under Section 17 of NCTE Act, 1993 to all such defaulting Teacher Training Institutions giving the last opportunity to furnish a representation supported with documents accompanied by an original affidavit within a period of 7 days from the date of issuance of show cause notice failing which the WRC will take appropriate decision as deemed fit in light of the provisions contained in the NCTE Act and extant Regulations (amended time to time)."

Accordingly, a final show cause notice was issued to the institution dated 14.01.2023.

11. **AND WHEREAS**, in response to the aforesaid, replies submitted by the institution vide letter dated 28.12.2022 received in WRC on 14.02.2023 & letter dated 01.02.2023 received in WRC on 22.03.2023.

12. **AND WHEREAS**, the matter was considered in the 378th meeting of WRC held on December 21-22, 2022, and the Committee has decided the following:-

"The original file of the Institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

• Initial recognition was granted for B.Ed. course of one year dated 23.08.2005 in the name of Aradhana P.T.C. College

The name of the institution in the recognition order has been corrected as "Aradhana College of Education" vide letter dated 04.05.2006.

• Revised order was issued for the B.Ed. course of two years dated 31.05.2015.

• Show cause notice dated 05.08.2016 was issued due to non-compliance of conditions as required under NCTE Regulations, 2014.

• Reply submitted by institution vide letter dated 12.08.2016 was considered by WRC in its 283rd meeting held on November 14-15, 2017 and accordingly, Show Cause Notice dated 17.11.2017 was issued to the institution for complying with the deficiencies mentioned therein.

• Reply vide letter dated 28.11.2017 submitted by the institution was considered by WRC in its 366th meeting held on 12th & 14th July 2022 and accordingly, a withdrawal order dated 28.10.2022 was issued to the institution.

- Being aggrieved, the institution preferred an appeal before the NCTE Appellate Authority and Appeal Committee of the Council concluded to remand back the case vide Order dated 30.11.2022 to WRC with a direction to consider the documents submitted in the appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulations, guidelines, and amendments issued from time to time. In the said order, the Appellant has been directed to forward to the WRC the documents submitted in the appeal within 15 days from the receipt of the order of the Appeal. The WRC is at the liberty to verify the submitted documents from the concerned issuing authority.
- Considering the direction of the Appeal Committee, the institution has not submitted any representation/documents to WRC-NCTE, and the stipulated time has already been exhausted.

In view of the above, the Committee decided that Show Cause Notice be issued to the institution u/s 17 of the NCTE Act to submit a reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

Accordingly, a Show Cause Notice was issued to the institution dated 02.02.2023.

- 13. **AND WHEREAS**, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 16.02.2023 received in WRC on 03.03.2023.
- 14. **AND WHEREAS,** the matter was considered by WRC in its 385th Emergent Meeting held on 17th May, 2023 and the Committee decided as under:-
 - "...The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:
 - Withdrawal order was issued to the institution on 28.10.2022.
 - The institution filed an appeal before the Appellate Authority at NCTE and Appellate Authority vide order dated 30.11.2022 remanded back the case to the WRC with direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulations, 2014.
 - The institution submitted reply vide letter dated 28.12.2022 received in WRC on 14.02.2023 and letter dated 01.02.2023 received in WRC on 22.03.2023.
 - Matter was again considered in 378th meeting of WRC held on December 21-22, 2022 and accordingly, an SCN dated 02.02.2023 was issued to the institution.
 - The institution submitted reply vide letter dated 16.02.2023 received in WRC on 03.03.2023.

In view of the above and in light of the directions of the Hon'ble Delhi High Court in the matter of Arihant College and Anr. v NCTE [W.P.(C)7260/2021] vide order dated 30.07.2021, the Committee decided to issue restoration order to the institution pending consideration of the reply of the institution vide letter dated 16.02.2023.

For consideration of the reply of the institution, the matter shall be placed again before the Committee in the ensuing meeting."

15. **NOW THEREFORE**, recognition of the Aradhana College of Education, Shree Prantij Taluka Kelavani Trust, Shantivan Campus, GH-6 Road, Sector-28 Gandhinagar-382028, Gujarat for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is hereby restored pending consideration of the reply of the institution vide letter dated 16.02.2023 and until a fresh withdrawal order is issued by the WRC, NCTE.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dated 31.05.2015.
